**O R D E R**

The SPIOs and the Appellant absent.

Perused the written statement date 14.12.2015 submitted by the District Mission Coordinator, SSA, Dhubri.

It has been submitted that after filing the First Appeal dated 03.05.2012, the Petitioner/Appellant withdrew his RTI Application through his letter dated 15.05.2012 addressed to the SPIO, District Mission Coordinator, SSA, Dhubri. A copy of said letter from the Petitioner is enclosed with the W/S.

However, this submission is not in consonance with the position stated in the Second Appeal and its date which is 03.08.2012. In the absence of the Appellant in the hearing, Commission is not in a position to determine as to why the Appellant had filed his Second Appeal, after submitting his letter dated 15.05.2012 to the SPIO, District Mission Coordinator, SSA, Dhubri stating that he had withdrawn his RTI Application of 29.03.2012.

The First Appeal dated 03.05.2012 was filed before the Deputy Commissioner, Dhubri. The Appeal was transferred by the Deputy Commissioner, Dhubri to the District Mission Coordinator, SSA, Dhubri on 07.05.2012, the latter being the appropriate authority.

No evidence has been received by the Commission of the District Mission Coordinator, SSA, Dhubri having disposed of the First Appeal as the FAA.

In view of the facts and circumstances brought out above, the District Mission Coordinator, SSA, Dhubri as FAA may consider and dispose of the First Appeal dated 03.05.2012 of the Appellant with a speaking order within 15 days from the date of receipt of this order.
