Neither parties present. However, a letter dated 16/12/2015 has been received from the First Appellate Authority/ Superintendent & Secretary, Purahuria Senior Madrassa, Karimganj requesting the Commission to fix another date of hearing providing at least 20 days time with effect from 16/12/2015 on account of being preoccupied on time bound official work. The date of hearing in respect of this instant Second Appeal case has already been changed twice, the previous date of hearing having been changed from 7/11/2015 to 20/11/2015 on the request of the same authority.

The same authority has again requested for change of the date of hearing without reporting whether the information sought for by RTI Applicant has been furnish to him.

In view of the facts brought out above, the Commission decides not to change the date of hearing and go ahead with a decision *ex parte*.
