Perused the Written Statement 23/12/2015 submitted by the SPIO. It has been submitted that the information with respect to the RTI Application had been handed over to Appellant/Petitioner on the date of the last hearing by the Commission on 20/3/2015 and that it was duly acknowledged by the Appellant/Petitioner. The SPIO has also submitted that he has not received any further complaint from the Petitioner after the case had been disposed of by the Commission on 20/3/2015.

The Appellant submitted that as he had detailed in his Complaint letter of 30/3/2015 based on which this hearing is held, there are discrepancies and anomalies in the copies of records handed over to him relating to authentication, sequence and completeness of the information he had sought for.
