## ORDER 05.1.2016

The Petitioner Smti. Deepjyoti Rajkhoa Borah is absent without information. The Public Authority is represented by Shri Manash Jyoti Bordoloi, District Programme Manager, NRHM as authorized by the Jt. Director of Health Services, Sonitpur. The complaint petition dtd 10.2.14 is taken up for hearing ex-parte in absence of the petitioner.

From perusal of the case records it is seen that the RTI petition dtd 21.8.13 filed by Smti. Deepjyoti Rajkhoa Borah before the Joint Director of Health Services, Sonitpur was received in his office on the same day with the office seal and the photocopy of the RTI petition submitted by the petitioner shows that the RTI petition was marked to the Superintenent of Kanaklata Civil Hospital, Tezpur and then to Dr. (Mrs) .Rini Duarah, SDM&HO 9Headquarter0, Tezpur. The District Programme Manager Shri Manash Jyoti Bordoloi stated that he did not receive this Commission's notice on this complaint case. He came to this Commission for attending hearing in two other cases.

From perusal of the RTI petition and the complaint petition dtd 10.2.14 it is seen that the applicant wanted information on conception and delivery of a baby on 31<sup>st</sup> July, 2013 at Kanaklata Civil Hospital, Tezpur by one Ms. Juri Borah. This appears to be a request for third party information. The district programme Manager of NRHM did not come prepared for this case, therefore, he could not say what action was taken on this RTI petition.

This Commission, therefore, directs the SPIO in the office of the Joint Director of Health Services, Sonitpur District to immediately process the RTI petition dtd 21.8.13 u/s 11 of the RTI Act, 2005 relating to third party information, and take a decision and communicate the same to the petitioner within 30 days from the date of receipt of this order. With the above order the RTI petition is remanded to the Joint director of Health Services, Sonitpur for disposal. The Complaint petition dtd 10.2.14 will be taken up for hearing, if found necessary, after the decision of the SPIO in the office of the Joint Director of Health Services, Sonitpur.
