**O R D E R**  
30.12.2015

The Applicant Shri Dulal Bora is present. The Public Authority is represented by Smt. Leena Das, Member Secretary of Assam State Commission for protection of Child Rights (ASCP CR). The Second Appeal petition dtd 6.6.13 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the applicant filed an RTI petition dtd 9.3.13 before the Chairperson of ASCPCR seeking information on the number of employees including officers in the Commission along with their names and positions. The applicant also sought information on the identity of a lady on the basis of a newspaper photo and whether she was an employee of the Commission. The Member Secretary of the Commission has made a written submission dtd 29.12.15 stating that the then Administrative Officer of the Commission furnished the required information to the applicant vide letter dtd 9.3.13. The names and posts held by the employees of the Commission was furnished copy of which has been enclosed along with the written submission dtd 29.12.15. Regarding the identity of a lady based on the paper cutting photograph, the Administrative Officer informed the applicant that the paper cutting photograph was not clear.

The Commission therefore, directs the applicant to furnish a clear photograph within 15 days from the date of receipt of this order so that the SPIO of ASCPCR can give the sought for information i.e. if the lady appearing in that photograph was working in the office of the ASCPCR and if so, in what capacity as on the date of the RTI petition dtd 9.3.13.

The Member Secretary of ASCPCR is directed to furnish the information within 15 days from the date of receipt of the clear photograph.

With the above orders, the Second Appeal petition dtd 6.6.13 is disposed of.
