From perusal of the case records it is seen that the Second Appeal petition dtd. 21.1.14 of the Petitioner was dismissed without admission by the then State Information Commissioner, Shri M.C. Malakar vide his order dtd 27.2.14. After dismissal of the Second Appeal petition, the then SIC ordered that to fulfill the objectives of the RTI Act, the SPIO of District Mission Coordinator, ASSA, Darrang District may furnish the information to the Applicant.
