The Petitioner/Appellant Shri Dulal Bora is absent. He prayed for deferment of the hearing due to a bereavement in the family. However, since the Public Authority represented by Shri Kulendra Talukdar, ACS, Joint Secretary, Govt. of Assam, Agriculture Department & SPIO accompanied by Shri Ranjan Jyoti Deuri, Jr. Administrative Assistant, Agriculture Department, Dispur are present, the Second Appeal petition dtd 5.11.13 is taken up for hearing ex-parte.

The SPIO & Jt. Secretary, Govt. of Assam, Agriculture Department has made a written submission dtd 22.12.2015 stating that the Petitioner was furnished with the required information by way of Govt. notification No. AGA.25/2013(19)163 dtd 19 July, 2012 suspending Md. Fayzul Islam, Assistant Executive Engineer, Agriculture, Bongaigaon.

This Commission observes that the suspension order does not mention the reason for placing Md. Fayzul Islam under suspension, which is mandatory in a suspension order. Since the sought for information is not contained in the suspension order, this Commission directs the SPIO & Joint Secretary, Agriculture Department to furnish other relevant document, if necessary photocopies of the relevant pages of the relevant file which records the reasons for which Md. Fayzul Islam was placed under suspension, within 15 days from the date of receipt of this order.

With the above order, the Second Appeal petition dtd 5.11.13 is disposed of.
