**O R D E R**  
18.12.2015

The Appellant/Petitioner Md. Abdur Ahmed is present. The Public Authority is represented by (1) Shri Jitendra Kr. Nath, BDO, Barkhetri Dev. Block, (2) Md. Hanif Uddin Ahmed, APO (C), DRDA, Nalbari, and (3) Anjima Daimari, EO (W&C), Barkhetri Dev. Block. The Second Appeal petition dtd 28.10.14 is taken up for hearing in presence of both the parties.

The Project Director, DRDA, Nalbari has sent a written submission dtd 17.12.15, which is entered into the case records.

From perusal of the case records it is seen that the petitioner Md. Abdur Ahmed filed his RTI petition dtd. 14.3.14 before the SPIO of Barkhetri Dev. Block, Mukalmua seeking various information on allotment of IAY houses and IAY beneficiaries from its inception in the Financial Year 2001-02 till the RTI petition dtd 14.3.14. The information should be available with the concerned GP i.e. No. 59 Mukalmua Narayanpur GP. The information sought for is admissible under the RTI Act although it covers a period of nearly 14 years.

This Commission therefore, directs the Secretary of No. 59 Mukalmua Narayanpur GP to allow the Petitioner to inspect all relevant records and documents pertaining to the RTI petition during office hour on any working day within 15 days from the date of receipt of this order and allow him to take notes and photocopies of relevant documents free of cost up to 50 copies and thereafter on payment of Rs. 2.00 for every additional copy.

The Block Development Officer, Barkhetri Development Block is directed to issue necessary instruction to Barkhetri Narayanpur GP to do the needful as ordered above.

With the above order, the Second Appeal petition dtd. 28.10.14 is disposed of.
