The Petitioner Shri Pradip Ch. Das as well as the Public to be represented by the PIO in the office of the Sati Radkhika Kala Kendra, Balighat Tiniali, PO- Jaysagar, Dist. Sivasagar, Assam are absent. Nor has any communication been received from the First Appellate Authority about the actions taken by him for disposal of the First Appeal petition dtd 4.10.13.

In the absence of both the parties it could not be ascertained whether Sati Radhika Kala Kendra is a Public Authority under the definition given in section 2(h) of the RTI Act, 2005.

This Commission therefore, directs the Petitioner Shri Pradip Ch. Das, retired Addl. Deputy Commissioner and respondent - the President, Mogorahati Gaon Panchayat, Dist. Sivasagar to be present with relevant materials and documents to help this Commission to arrive at a decision on this point on the next date of hearing. The President incharge of SRSKK is also directed to make a written submission about the actions taken by him on the RTI petition dtd. 24.7.13.
