The petitioner Smti Nalini Changmai and the public authority to be represented by the SPIO of the office of CDPO, Tingkhong ICDS project, Rajgarh, Dist- Dibrugarh both are absent without information.

However, the EAC and PIO of the office of the Deputy Commissioner, Dibrugarh has sent a written submission dated 1st December, 2015 asking the SPIO of CDPO of Tingkhong ICDS project to apprise the Commission about the steps taken to dispose the first appeal petition dated 15-5-2013.

The Registry of this Commission informed the Commission that when contacted over phone, the petitioner said that due to serious illness of his elder brother, he could not attend today's hearing. He has in the meanwhile been furnished some information by the CDPO to Tingkhong ICDS Project. He has however, stated that he was not fully satisfied with the information received.

This Commission, therefore, directs the CDPO, Tingkhong ICDS project, Rajgarh, Dist- Dibrugarh to allow the petitioner to inspect the relevant documents, records and files pertaining to his RTI petition , during office hours on any working day within 15 days from the date of receipt of this order and allow him to take notes as well as photo copies of the documents sought for by him free of cost up to 25 copies and thereafter on payment of Rs. 2 for every additional copy.

With the above order the second appeal petition dated 16-7-2013 is disposed of.
