**O R D E R**

The petitioner/ appellant Sri Gautam Borah is absent without any information. On the last date of hearing on 6-4-2015 also the petitioner was absent.

The public authority is represented by Sri Bidit Das SPIO and Election Officer, Deputy Commissioner's office, Jorhat.

The SPIO has submitted a copy of his letter No. JMC. 22/2013 dated 16<sup>th</sup> December, 2015 addressed to Sri Gautam Borah the petitioner, giving him detailed information on the 3 points raised in his RTI petition dated 22-8-2013. The Commission directs the SPIO to send the required information by Special Messenger, to reach the petitioner **within 7 days from today.**

The Commission has also perused the reply dated 14<sup>th</sup> May, 2015 submitted by the Deputy Commissioner, Jorhat Sri Solanki Vishal Vasant, IAS and reply dated 12<sup>th</sup> May, 2015 submitted by Sri Dwijen Singh, Additional Deputy Commissioner and SPIO of the Administration Branch of Deputy Commissioner's Office, Jorhat.

The Deputy Commissioner as well as the Addl. Deputy Commissioner have admitted that there was inadvertent error and delay in their responses to the RTI petition. They have prayed for sympathetic consideration of the matter and not to impose any penalty. Their prayer is accepted with the observation that in future such error and delay be avoided in dealing with RTI matters.

With the above order the petitions dated 22-1-2014 and 6-5-2015 are disposed of.
