O R D E R

The petitioner Sri Mridul Phukan is absent without information. The public authority is represented by Sri Kuldip Talukdar, Sub- Inspector of Schools, Nazira and Sri H.N.Gogoi, Statistical Assistant in the office of D.I of Schools , Nazira.

A written statement dated 19th November, 2015 has been received from the petitioner stating that he has not received the required information till now.

However, from the records, it is seen that the BEEO, Nazira vide his letter dated 26-12-2012 furnished point-wise replies to the petitioner Sri Mridul Phukan.

The second appeal petition dated 14-2-2013 is mainly related to allegation of furnishing incomplete information by the BEEO, Nazira. This Commission, therefore, directs the BEEO, Nazira to allow the petitioner to inspect the relevant office records/ documents/ files relating to his RTI petition dated 28-9-2012 and allow him to take notes and photo copies of documents free of cost up to 25 copies and thereafter on payment of Rs. 2/- for every additional copy on any working day within 15 days from the date of receipt of this order. The petitioner will give at least 2 days advance notice informing the BEEO for his intention to inspect the records.

While furnishing the required information to the petitioner/appellant the BEEO will refer to Section 2(f) regarding the meaning of information and Section 2(j) regarding the meaning of Right to Information

The BEEO will also take care to comply with the provisions of Section 8 of the RTI Act regarding the information exempted from disclosure and Section 11 relating to disclosure of third party information like personal details, including Service Book etc of third parties.

With the above order the second appeal petition is disposed
