<u>ORDER</u>

The petitioner Mrs. Subera Begum as well as the public authority to be represented by the SPIO of Sivasagar Zila Parishad both are absent without information.

The prayers dated 19-1-2013 followed by reminder dated 28-1-2013 filed before this Commission are taken up for consideration ex-parte in the absence of both the petitioner and the public authority.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 4-10-2012 before the PIO, Sivasagar Zila Parishad followed by first appeal petition dated 7-11-2012 before the CEO, Sivasagar Zila Parishad.

On perusal of the RTI petition it is seen that the sought for information are admissible under the RTI Act.

Getting no response she filed a complaint petition dated 19-1-2013 before this Commission followed by a reminder dated 28-1-2013 in which she prayed for the intervention of this Commission so that she gets the required information expeditiously.

Treating the reminder dated 28-1-2013, as a second appeal petition this Commission gives the CEO, Sivasagar Zila Parishad one more and the last opportunity to furnish the required information to the petitioner by allowing her to inspect the relevant office records and documents during office hours on any working day within 15 days from the date of receipt of this order and allow her to take notes and also photo copies of required documents free of cost up to 50 copies and there after on payment of Rs. 2/- for every additional copy.

With the above order the second appeal petition dated 19-1-2013 and 28-1-2013 are disposed
