O R D E R

The petitioner Sri Dulal Bora is absent without any information. The public authority to be represented by the SPIO of the office of DGP, Ulubari, Guwahati is also absent without any information.

However, one ASI Sri Paresh Bora appeared with a copy of letter dated 20th July, 2013 from the Asstt. Inspector General of Police and PIO of Assam Police Headquarters, addressed to Sri Dulal Bora, furnishing him the required information in response to his RTI petition dated 8-6-2013.

It appears that the AIGP and PIO has replied to the RTI petition dated 8-6-2013 on all the points except the petitioner's question as to why he had to file the first appeal petition. This appears to be superfluous, because the appellant himself is expected to know equally well, if not better, the reasons as to why he had to file his appeal petitions.

However, from the first and second appeal petitions of the petitioner, it seems that he did not receive AIGP and PIO's letter dated 20th July, 2013.

This Commission, therefore, directs the AIGP and PIO of the office of DGP to send one more copy of his letter dated 20th July, 2013 to the petitioner Sri Dulal Bora by special messenger and obtain a receipt from him within 7 days from the date of receipt of this order.

This Commission also directs the DGP, Assam to advise his PIO to attend hearings of this Commission personally, and if due to compelling circumstances the PIO is not able to attend the hearings himself, then he may send a representative, not below the rank of Deputy Superintendent of Police.

With the above order the second appeal petition is disposed of
