O R D E R

The petitioner Sri Shyamal Kumar and the public authority as represented by Sri Niren Sarma, SPIO and MVI of the office of DTO, Kamrup (Metro), Guwahati both are present. The second appeal petition dated 25-11-2013 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner Sri Shyamal Kumar vide his RTI petition dated 23-8-2013 filed before the DTO, Kamrup (Metro) (Registration and Licensing) wanted 4 (four) sets of information some of which were third party information like Income Tax returns of the employees of DTO's office.

In any case, the petitioner/ second appellant has made a written submission today stating that even if he is given the information now, after a lapse of more than 2 years of filing of his application, it will not serve any useful purpose. He has , therefore, prayed for allowing him to withdraw his second appeal petition.

He had, however, orally deposed before this Commission that the reason behind the filing his RTI application on 23-8-2013 was that he wanted to know the particulars of vehicle No. AS-01-AC-6382 which he had purchased in the year 2013 from one Sri Dipak Rao.

In view of the above the Commission directs the SPIO and MVI of the office of DTO, Kamrup (Metro) to allow the petitioner Sri Shyamal Kumar to inspect the office records within 15 days from the date of receipt of this order and take notes of relevant documents as may be available. With the above order the second appeal petition is disposed of.
