The Petitioner is present.

The Public Authority is represented by Dr. Balen Medhi, i/c, Chenga Block PHC, Dr. Pramathesh Sarma, DIO, Barpeta.

Perused the case records as well as the Written Statement dated 2/1/2016 submitted by SDM & HO, Chenga Block PHC, Barpeta with enclosures. Enclosing photocopies of the relevant portions of the Register of Death and Birth it has been submitted that the death certificate of the person concerned was issued in 1998 by the SDM & HO of the time and the certificate for the person of the same name was issued in 2005 by the SDM & HO of the time based on the orders of an Executive Magistrate.

The Appellant submitted that although he has indeed received the information, he has not received the clarification as regards issue of two death certificates in the name of Late Delowar Hussain.

Considering the facts brought out above, the Commission is of the view that the Appellant had been furnished by the SPIO the information which is available on record and that his grievance relates to the issue of double death certificate in respect of Late Delowar Hussain indicating two dates of death and concludes that this is a matter which is beyond the jurisdiction of this Commission and that the Appellant will have to approach other fora for resolution of his grievance.

With this, the Second Appeal Petition is disposed of.
