Dr. Umesh Phangcho, SPIO & Joint Director (i/c) of Health Services, Hailakandi is present.

Perused the case records including the Written Statement submitted by the SPIO dated 3/12/2015, which was received in the Commission after the previous date of hearing which was 7/10/2015.

Through the W/S, it has been submitted that the information collected from different wings of the department had been furnished to the Appellant through a letter dated 12/12/2013. Further, it has been submitted that the delay in furnishing the information happened in the process of information gathering.

Second Appeal Petition was filed with the Commission because of what was stated as insufficient and inexact information supplied to him. In the absence of the Appellant, the Commission is not in a position to determine as to what part of the information the Appellant had sought for is wanting. JDHS, Hailakandi has submitted that the list of beneficiaries of LSM appears to be the information that was not furnished to the RTI Applicant.

In view of the above, the Commission hereby orders that the SPIO shall reexamine the details of the information already furnished to the Appellant, determine the gap in the information so furnished and furnish the same after collecting it from the concerned Block PHC.

The Second Appeal Petition is hereby disposed of.
