The Appellant absent without information.

The SPIO/ Headmistress present along with her predecessor.

Perused the case records. It is seen that the Second Appeal was filed with the Commission on not receiving any response to his Petition for information relating to inspection report relating to staff by the District Elementary Education Officer, Cachar.

Perused the W/S submitted by DEEO, Cachar dated 08.01.2016 and the W/S dated 10.01.2016 by the Ex- Headmaster of Mazirgaon M.E. School, Sonaimukh, Cachar.

Vouching the content of the W/S of her predecessor, the Headmistress submitted that delay in providing the information happened on account of the time taken to implement the said report of the DEEO, Cachar and that the copies of the related documents sought for by the Petitioner are ready to be provided to him.

In view of the above facts, the Commission hereby orders that the information sought for by the Petitioner through his Application dated 24.08.2012 be furnished to him by the Headmistress, Mazirgaon M.E. School, Sonaimukh, Cachar, free of cost, within a period of 10 days of receipt of this order.

Further, the Commission has not received any evidence of the First Appellate Authority /DEEO, Cachar having disposed of the First Appeal dated 28.02.2013.

The Commission, therefore, hereby orders that the FAA shall consider and dispose of the said First Appeal, with a speaking order, within 21 days of receipt of this order.

A copy each of the RTI Application dated 24.08.2012 and the First Appeal dated 28.02.2013 be forwarded to the FAA along with the copy of this order.

With this, the Second Appeal Petition is disposed of.
