Neither the SPIO nor the Appellant present.

No Written Statement has been received from either party. Therefore, the Commission has no information on the case subsequent to receipt of the Second Appeal dated 12/7/2012.

The case records indicate that the Appellant had filed the Second Appeal as he did not receive the information he had sought for inspite of filing the First Appeal dated 29.03.2012 and passage of nearly four months from the date of filing his RTI Application.

It is seen that instead of disposing of the First Appeal in accordance with the RTI Act, 2005, the Directorate of Madrassa Education Assam transferred the same through their letter dated 18/5/2012 to the heads of the aforementioned two schools which ought not to have been done.

In view of the facts brought out above, the Commission hereby orders that the information sought for by the Appellant shall be furnished to him by the heads of the aforementioned two schools, free of cost, within a period of 10 days of receipt of this order.

Further, the Commission hereby orders that the FAA/Director of Madrassa Education Assam shall consider and dispose of the said First Appeal, with a speaking order, within a period of 21 days of receipt of this order.

A copy of the RTI Application and First Appeal dated 29.03.2012 be forwarded to the FAA.

With this, the Second Appeal Petition is hereby disposed of.
