O R D E R 13.01.2016

The Public Authority to be represented by the SPIO of the Commissioner of Excise, Govt. of Assam is absent. However, he has sent a written submission dated 11-1-2016 stating that the required information had already been furnished to the applicant vide Excise Commissioner's letter dated 17<sup>th</sup> April, 2013 in response to the petitioner Sri Dulal Bora's RTI petition dated 20-3-2013.

The appellant Sri Dulal Bora is also absent, but he has sent a written submission dated 13-01-2016 praying for deferment of the date of hearing due to his illness.

However, since the concerned Public Authority had already furnished the required information to the applicant vide their letter dated 17-4-2013, hearing of the Second Appeal Petition dated 13-6-2013 does not appear to be necessary.

If the applicant wants any further clarification, then this Commission directs the SPIO in the office of the Commissioner of Excise, Govt. of Assam to allow the Appellant to inspect relevant office records and documents during office hours on any working day, within 15 days from the date of receipt of this order, and also allow him to take notes up to 20 pages and thereafter, on payment of Rs. 2/- for every additional copy.

Further, if the applicant wants to make any further submission before the Commission, he may do so within 30 days from the date of receipt of this order.

With this order, the Second Appeal Petition dated 13-6-2013 is disposed of ex-parte.
