O R D E R

Sri Atul Ch. Baruah, BDO, Dhalpukhuri Development Block and Md. Sofiul Alom, SPIO in the office of the PD, DRDA, Nagaon present.

The Complainant, Sri Bijoy Chakraborty present.

Perused the case records. It is seen that the RTI Application dated 06.05.2013 had been inadvertently treated as two separate cases, one as Second Appeal and the instant case as a Complaint case. It is also seen that in respect of the Second Appeal case, no. SIC/NGN/85/2013 a hearing was heard and order passed dated 10.12.2015. It had been noted in the order that the information sought for by the Applicant had been furnished by the BDO, Jugijan Development Block and that the BDO, Dhalpukhuri Development Block was ready with the information to be collected by the Petitioner. It had been ordered that the Petitioner would collect the information, if he so desired.

The Complainant in the instant case submitted that he had since received the information from the BDO, Dhalpukhuri Development Block and that some information which are not available with the BDOs such as relates to SHG Training Centre, SHG Hut, Weaving shed, Market shed, Anganwadi school, name of the person/officer/contractor who supervised the construction work of these schemes, total amount of interest money in all the funds received by DRDA, Nagaon including MGNERGA and IAY.

In view of the facts brought out above, the Commission hereby orders that the SPIO in the office of the PD, DRDA, Nagaon shall provide, free of cost, within a period of 21 days of receipt of this order, the part of the information which could not be provided for by the abovementioned two BDOs and have been specified above.

It is seen that the PD, DRDA, Nagaon to whom the First Appeal dated 14.07.2013 had been submitted by the Petitioner has not been disposed of. The Commission therefore hereby orders that the PD, DRDA, Nagaon shall consider and dispose of, with a speaking order, the said First Appeal, within 30 days of receipt of this order.

With this, the Complaint case is dispose of.
