<u>O R D E R</u>

The petitioner Sri Dulal Bora is present. The public authority is represented by (1) Sri Ajit Kr. Borah, PIO and Superintending Engineer (P) office of the Chief Engineer, PWD (Roads) and (2) Sri Motilal Pegu, APIO and Executive Engineer (IBRC) Office of the Chief Engineer, PWD (Border Roads).

The second appeal petition dated 20-6-2013 is taken up for hearing in presence of both the parties.

The PIO and S.E has made a written submission dated 11th January, 2016 stating that the RTI petition was transferred to the Asstt. Executive Engineer, IBRC branch of the office of the Chief Engineer, PWD (Roads) under Section 5(4) of the RTI Act.

The PIO has also mentioned that information against point No.-1 was furnished to the appellant vide letter datd 5-4-2013, copy of which has been enclosed with the W/S.

However, on perusal of the Written Statement it is seen that it is with reference to another application filed by the applicant and about the same road. Hence the W/S is returned to the PIO for filing against the relevant other case.

From perusal of the RTI petition, it is seen that the applicant wanted to know the following information about the road from Azara to Khanapara, connecting the VIP road – (1) length and breadth of the road, (2) point up to which construction have been completed on the date of the RTI petition dated 9-3-2013 (3) as per DPR, the scheduled date of completion of construction of the road as per DPR and (4) copy of the detailed Plan & Estimates of the road, ie., copy of the DPR.

The sought for information appears to be admissible under the RTI Act. This Commission, therefore, directs the PIO of the office of Commissioner, PWD (Roads) to furnish the information with regard to Point No. 1 2 3 within 15 days from the date of receipt of this order.

As regards point No. 4, the Commission is of the view that the DPR is a voluminous technical document. This Commission, therefore, directs the SPIO to allow the applicant Sri Dulal Bora to inspect the DPR during office hours on any working day within 15 days from the date of receipt of this order and allow him to take notes and photo copies of any part there of , free of cost up to 20 copies and thereafter, on payment of Rs. 2/- for every additional copy.

With the above order the second appeal petition dated 20-6-2013 is disposed of.
