O R D E R

The petitioner Sri Ranjan Daimari is absent without information. The public authority is represented by Sri Kiran Kr. Kardong, Accountant of Sonitpur Zila Parishad, Tezpur.

The second appeal petition dated 24-12-2013 is taken up for hearing ex-parte in the absence of the appellant.

From perusal of the case records, it is seen that in response to the RTI petition dated 27-8-2013 the PIO of Sonitpur Zila Parishad furnished certain information to the petitioner, vide letter dated 9th October, 2013. Being not satisfied with the information furnished the applicant filed first appeal petition dated 21-10-2013 before the CEO, Sonitpur Zila Parishad followed by Second Appeal Petition dated 24-12-2013 before this Commission.

In the absence of the petitioner it could not be ascertained , as to which part of the information furnished is incorrect or incomplete, according to him. The PIO of Sonitpur Zila Parishad present today, deposed that the information furnished vide letter dated 9th October, 2013 are in respect of on-going schemes at the relevant point of time and that no schemes were completed till that time. This being the case according to the PIO of Sonitpur Zila Parishad , he is directed to inform the applicant accordingly within 15 days from the date of receipt of this order. The PIO is also directed to allow the applicant , if he so desires, to inspect the relevant office records and documents, during office hours on any working day within 30 days from the date of receipt of this order and allow him to take notes and photo copies of documents sought for by him in connection with the RTI application, free of cost up to 20 copies and thereafter on payment of R. 2/- for every additional copy.

With the above order, the second appeal petition is disposed of.
