**O R D E R**

The appellant Sri Dulal Bora is absent without any information. The public authority is represented by (1) Sri Mukul Kathar, SDO (Sadar) and SPIO, Deputy Commissioner's Office, Kamrup (Metro) (2) Smti Sarmistha Borah, Asstt. Commissioner, Kamrup (Metro) and (3) Smti Mororama Morang, Circle Officer (A), Dispur Revenue Circle.

The second appeal petition dated 13-7-2013 is taken up for hearing ex-parte in the absence of the appellant.

From perusal of the case records it is seen that vide his RTI petition dated 15-3-2013 the petitioner wanted to know the No. of Government and Non- Government offices within the territorial jurisdiction of the Deputy Commissioner, Kamrup (Metro).

By the second part of his RTI application he wanted information on the No. of Nationalized Banks and the number of Non-Nationalized Banks within the territorial jurisdiction of Deputy Commissioner, Kamrup (Metro)

The SPIO of Deputy Commissioner's office submitted orally that the Deputy Commissioner's office do not maintain the information of all Govt. Offices of all departments within the territorial jurisdiction of Deputy Commissioner, Kamrup (Metro)

The Commission , therefore, directs the SPIO to inform the petitioner accordingly within 7 days from the date of receipt of this order.

As regards the second part of the RTI petition relating to information on Nationalized and non Nationalized Banks, the SPIO has submitted that they do not maintain such records in the office of the Deputy Commissioner.

This Commission is of the view that the District Lead Bank Officer or SLBC will be the appropriate authority to furnish this information. This Commission, therefore, directs the SPIO of Deputy Commissioner's Office to transfer the second part of the information to the District Lead Bank Officer to furnish the information within 30 days from the date of receipt of the communication from Deputy Commissioner's office with a copy to the petitioner.

In view of the above, the second appeal petition is disposed of..
