O R D E R

The petitioner Sri Govinda Rajbangshi is present. The public authority is represented by Sri Rupak Bhattacharjee, SPIO, APCDCL.

The matter is taken up for hearing in presence of both the parties pursuant to earlier orders dated 27-11-2015 and 22-12-2015 of this Commission.

The Managing Director, APCDC Sri J. Malakar has made a written submission dated 11th January, 2016, which is entered into the case records. In his written submission the M.D has stated that being the Superintendent of the office of APCDCL, Sri Govinda Rajbangshi, the appellant can have access to all documents of the office with due permission of the M.D. The M.D has also submitted that he has already directed the SPIO to hand over the related files on " Rubber Day Celebration etc." to the petitioner for his perusal.

The SPIO has submitted that the relevant file Nos are (1) APCDC/BIS/NSY-2 and file No., APCDC/Plan-46(C)Vol-2.

In view of the direction already given by the Managing Director and readiness of the SPIO to handover the same to the appellant for his perusal, this Commission does not seem to have any further cause of action. The two files were handed over to the petitioner by the SPIO in presence of this Commission today. The petitioner also acknowledged receipt of the same in writing.

This Commission also advises the appellant not to bring internal office disputes, which can be resolved within the office, before this Commission for redressal of their grievances. He is further directed to note that the Information Commissions are not trial Courts or the appropriate forum for redressal of grievances and for resolution of disputes other than those related to providing of information under the RTI Act.

With the above order the second appeal petition is disposed of.
