O R D E R

The petitioner Sri Dulal Bora is present. The public authority is represented by Dr. Bhupen Talukdar, Joint Director and SPIO of the Directorate of Secondary, Education, Assam.

The second appeal petition dated 6-6-2013 is taken up for hearing in presence of both the parties in pursuance of earlier order dated 21-12-2015.

The Director of Secondary Education, Assam has made a written submission dated 20th January, 2016 in compliance with this Commission's earlier order dated 21-12-2015 . In his written submission he has listed the categories of posts under the Directorate of Secondary Education indicating against each category of posts the concerned appointing authority. As has already been noted in earlier order dated 21-12-2015 the applicant has already been given information regarding the retired and deceased employees , for whom the Director is the appointing authority.

This Commission now directs the Joint Director and SPIO of the office of the Director, Secondary Education to furnish a copy of their letter dated 20th January, 2016, mentioned above, which shows that the Inspector of Schools as the appointing authority in respect of Assistant Teachers, field level LDAs and Gr.-IV employees. As already advised by the Director of Secondary Education, the applicant may now file fresh RTI petitions to the concerned appointing authorities, i.e., the Inspector of Schools of various districts for eliciting information about the teachers already retired and deceased , for whom the Inspector of Schools are the appointing authorities.

In view of the above, the second appeal petition dated 6-6-2013 is disposed of.
