## ORDER

The petitioner Sri Dulal Bora is present. The public authority is represented by (1) Sri Hemanta Kr. Sarma, Superintendent of Taxes, Guwahati Unit-'D', (2) Sri Sandeep Chanda, Suptdt of Taxes, Guwahati Unit 'D'.

The second appeal petition dated 10-6-2013 is taken up for hearing in presence of both the parties.

The petitioner Sri Dulal Bora filed his RTI petition dated 28-2-2013 before the Deputy Commissioner, Kamrup (Metro). It was transferred by the Deputy Commissioner's office to the Superintendent of Taxes dated 18-4-2013. The Asstt. Commissioner of Taxes, Unit-'D' Sri P. k. Sinha has sent a written submission dated 28<sup>th</sup> January, 2016, stating that vide letter dated 4<sup>th</sup> May, 2013, the petitioner was requested to furnish documentary evidence of alleged collection of Taxes by the earstwhile Cinemax, now PVR , so as to initiate necessary action against the party concerned. The Asstt. Commissioner of Taxes also mentioned that till  $28^{th}$ January, 2016 he did not receive any response from the petitioner.

The petitioner Sri Dulal Bora submitted that after his RTI petition the concerned authorities of the State Govt. took necessary action against the delinquent Multiplex Cinema with which he is satisfied and he and he also subsequently got the information from the concerned authorities.

In view of the above, the second appeal petition is disposed of and the matter is closed.
