<u>ORDER</u>

The petitioner Sri Dulal Bora is present. The public authority is represented by Ajit Kr. Bora, PIO and Superintending Engineer (P), Office of the Chief Engineer, PWD (Roads), Assam (2) Sri Motilal Pegu, Executive Engineer, PWD, Office of the Chief Engineer, PWD (Border Roads) and (3) Sri Dilip Terang, Superintendent, Office of the Chief Engineer PWD (Roads).

The second appeal petition dated 20-6-2013 is taken up for hearing in presence of both the parties.

The PIO has sent a written submission dated 2nd February, 2016, narrating the actions taken by him on the RTI petition dated 9-3-2013

From perusal of the case records, it is seen that the petitioner Sri Dulal Bora submitted his RTI application dated 9-3-2013 before the Commissioner, PWD, seeking information on the construction of road from Azara to Khanapara via Koinadhara connecting the VIP road.

The PIO and Chief Engineer, PWD (Roads) deposed that the information regarding the tendering process for construction of this road has already been furnished to the applicant.

As regards the second part of the RTI petition relating to compensation paid to the people who lost their land for construction of this road, the RTI petition was transferred to the Deputy Commissioner, Kamrup (Metro) vide letter dated 5th April, 2013 of the Suptdg. Engineer and PIO of the office of the Chief Engineer, PWD (Roads).

The petitioner stated that he has not received any information regarding the compensation paid against the land acquisition.

This Commission, therefore, directs the Deputy Commissioner, Kamrup (Metro) to furnish the required information to the petitioner within 30 days from the date of receipt of this order.

With the above order, the second appeal petition is disposed of.
