**O R D E R**

The petitioner Sri Samiran Saikia is absent without information. The public authority is represented by Sri Samiran Bora, Circle Officer and SPIO, Jorhat East Revenue Circle.

The second appeal petition dated 1-2-2014 is taken up for hearing ex-parte in the absence of the petitioner.

From perusal of the case records it is seen that the applicant filed his first appeal petition dated 3-12-2013 before the Deputy Commissioner, Jorhat seeking information on the land particulars of Late Sadananda Saikia, situated in several villages falling under Sawkhat Mouza. The RTI application was transferred to the Circle Officer, Jorhat East Revenue Circle, who on 6-2-2014 informed the Addl. Deputy Commissioner, Jorhat that the required information could not be furnished because the petitioner did not mention the name of the Topsils. The Circle Officer deposed before this Commission today that the applicant never contacted them. However, on receipt of the notice from this Commission, the Circle Officer has compiled the information sought for by the petitioner and made a written submission dated 27-1-2016 before this Commission communicating the sought for information.

In view of the above, the Commission directs the Circle Officer to furnish the information, as compiled by him to the applicant within 15 days from the date of receipt of this order. If the applicant wants to have any further information, he may be allowed to inspect the relevant documents and records in the office of Circle Officer, Jorhat East Revenue Circle Office within 15 days after receiving the information to the Circle Officer, as directed above.

With the above order the second appeal petition dated 1-2-2014 is disposed of.
