**O R D E R**

The Public Authority is represented by Sri Nitul Kumar Haloi, SDE, office of the Nagaon Electrical Sub-Division-II assisted by Sri Bikram Jit Dey. A Written Statement dated 05.02.2016 received.

The Appellant/Complainant absent without information.

Perused the case records. It is seen that the case was heard by the Commission on 17.06.2013 and in addition to making certain observations, an order was passed to the effect that the information available/maintained in the office of the Deputy Manager will be furnished to the Appellant, free of cost, within 10 days of receipt of that order.

Perused the said W/S. It has been submitted that in compliance with the Commission's said order, information had been provided to the Applicant through letter dated 21.06.2013. With reference to the observations of the Commission in the said order relating to imposition of penalty, the circumstances in which furnishing of the information was delayed has been explained.

Perused the complaint letter of the Petitioner dated 16.07.2013. The complaint is that the information received by him in compliance with the Commission's abovementioned order was incomplete, erroneous and that there was an effort to mislead the Commission and the Petitioner. It is seen however that the Complainant has not specified the areas in which the information received by him was incomplete or erroneous. Further, information on this could not be gathered from the Complainant because of his absence from today's hearing and any written communication in response to the Commission's hearing notice of 28.01.2016.

In view of the facts brought out above, the Second Appeal/Complaint case is hereby disposed of.
