The Public Authority is represented by Md. Abdul Khayer, BEEO, Juria assisted by Md. Sabbir Ahmed Osmani, Head Mudarris, Kawaimari Pre-Senior Madrassa.

The Appellant Present.

The SPIO has submitted a Written Statement dated 9/2/2016. It has been submitted that the RTI Application dated 5/11/2012 had been transferred to the Head Mudarris of the concerned school namely, Kawaimari Pre-Senior Madrassa u/s 6 (3) of the RTI Act, 2005 through letter dated 14/11/2012 and subsequent reminders. Perused the copies of the said letters. It has further been submitted that the required documents in connection with the information sought for have now been collected from the said school and is ready to be provided to the Petitioner.

Heard the Appellant. It was reiterated that no information have been received.

It is observed that the SPIO transferred the RTI Application u/s 6 (3) of said Act instead of collecting the information by seeking assistance of the Head Mudarris of the said School. The proper procedure to be followed has been explained to the BEEO during the hearing.

No evidence has been received in the Commission of the First Appellate Authority (FAA)/BEEO, Juria having disposed of the First Appeal dated 11/2/2013 submitted by the Appellant.

In view of the facts brought out above, the Commission hereby orders that the information sought for by the Appellant shall now be provided by the SPIO by post, free of cost, within a period of 10 days of receipt of this order.

It is also hereby ordered that BEEO, Juria as FAA shall consider and dispose of the First Appeal dated 11/2/2013, with a speaking order, within a period of 21 days of receipt of this order.
