The Public Authority is represented by Md. Amir Ali, U.D.A. along with Sri Uday Deka, B.E.E., Jugijan BPHC, Nagaon. No Written Statement submitted by the representatives of the SPIO.

The Complainant absent without information.

Heard the representatives of the SPIO. It was submitted that information had been furnished partially to the Complainant and that some information relating to third party could not be provided.

The First Appellate Authority (FAA)/Additional Deputy Commissioner, i/c Hojai Sub-Division, Nagaon has not apprised the Commission about the steps he had taken to dispose of the First Appeal either by a Written Submission/or by deputing his authorized representative to the hearing which he was directed to do through the hearing notice of the Commission.

In view of the facts brought out above, the Commission hereby orders the following-

- 1. The SPIO shall review the RTI Application dated 21.09.2012 of Md. Bilal Ahmed and the information that had been furnished to him, and furnish the remaining information, free of cost, or explain in writing to the Petitioner if any part of the information is not available to be furnished, within a period of 10 days of receipt of this order.
- 2. The FAA/Additional Deputy Commissioner, i/c Hojai Sub Division, Nagaon shall hear the First Appeal of the Appellant dated 05.04.2013 and pass an appropriate speaking order in compliance with the relevant provisions of the RTI Act, 2005, within a period of 21 days of receipt of this order.

With this, the Complaint case is disposed of.
