## ORDER 05.02.2016

Neither party present. However, a Written Statement dated 4/2/2016 received from the SPIO/District Development Commissioner, Cachar, Silchar.

From the case records it is seen that the Appellant had submitted an Application dated 1/9/15 under the RTI Act, 2005 to the SPIO/A.D.C., office of the Deputy Commissioner, Cachar seeking (1) documentary proofs in compliance with the order dated 8/5/15 passed by the D.C., Cachar and (2) action taken report in respect of his registered letter dated 25/5/15 addressed to the D.C., Cachar relating to F.I.R. to O/C, Sadar. He filed his First Appeal dated 26/10/15 to the D.C., Cachar after not receiving any information from the SPIO.

He then preferred the Second Appeal with the Commission dated 14/12/15 on the ground that First Appellate Authority had not passed any order.

Perused the aforementioned W/S submitted by the SPIO. The submission, in essence, is that the SPIO has responded to the Applicant through letter no. CAJ.6/Appeal Case/2015/39 dated 12/1/2016. It has been added that in compliance with the order of the D.C., Cachar referred to by the Applicant, SDO, Sadar filed F.I.R. to the O/C, Sadar Police Station through letter no. CAP(C)1/2001/184 dated 16/5/2015 and also wrote letter no. CAP(C)1/2001/185 dated 16/5/2015 to (1) Chairman, S.C. Development Board, Silchar (2) President Secretary, Asom Anusuchit Jati Parishad, Silchar (3) all Circle Officers, Cachar District (4) SDWO, Cachar, Silchar requesting them to furnish the relevant counter foils/record, if available with them.

It is seen that a copy of the said W/S dated 4/2/2016 has been endorsed to the Appellant along with copies of the documents.

In view of the submission by the SPIO, the Second Appeal Petition is hereby disposed of.

The Appellant will be at liberty to approach the Commission again, if he is not satisfied with the information given by the SPIO through the said W/S and the follow up action taken thereon.
