However, a letter dated 06.02.2016 has been received from the S.P., Cachar, Silchar requesting fixing of another date on account of late receipt of the Commission's notice.

Perused the W/S dated 07.02.2016 received from the DIGP (SR), Assam. It has been submitted that on receipt of the First Appeal dated 18.12.2012 on 24.12.2012, the Appellant had been asked to appear before the First Appellate Authority (FAA) and that the Appellant had not done that. It has further been submitted that the S.P., Cachar was instructed to reply to the Appeal made by the Appellant to the DIGP (SR), Assam and that the matter was disposed of by the S.P. Cachar through memo no. G/RTI/2013/885-86 dated 06.04.2013. The FAA has enclosed a copy of the said memo of S.P. Cachar.

From the said enclosed letter, it is seen that certain information had indeed been furnished to the Appellant/Applicant which was subsequent to the date of his Second Appeal. In the absence of the Appellant and any communication from him, the Commission could not determine whether he was satisfied with the reply given by the S.P. Cachar.

Based on the said reply and information, the Second Appeal Petition is hereby disposed of.

Should the Appellant not be satisfied with the said information supplied to him, he shall be at liberty to approach the Commission again.
