The SPIO, office of the BDO, Hailakandi Development Block absent without information. No Written Statement received which was sought through the Commission's hearing notice no. SIC/HLK/7/2015/04 dated 22/1/2016. The SPIO has also not submitted any explanation as to why penalty shall not be imposed on him/her Under Section 20 (1) of the RTI Act, 2005 for his/her failure to furnish the information to the Applicant within the stipulated period of 30 days.

The Appellant absent without information.

The First Appellate Authority (FAA)/BDO, Hailakandi has not apprised the Commission about the steps he had taken to dispose of the First Appeal either by a Written Submission/or by deputing his authorized representative to the hearing which he was directed to do through aforementioned hearing notice of the Commission.

Perusal of the case records indicate the following sequence of significant dates:

- 05.11.2014 RTI Application filed with the SPIO, office of the BDO, Hailakandi Development Block, Hailakandi.
- 09.12.2014 First Appeal filed with the BDO, Hailakandi.
- 20.01.2015 Second Appeal filed with the Commission.

As the issue of providing the information to the Applicant under the RTI Act, 2005 is a fairly straightforward matter, the Commission has decided to go ahead with the hearing *ex parte*.

In the absence of the SPIO and Written Statements from him and the FAA, and also the absence of the Appellant, the Commission could not determine the latest position relating to furnishing of the information sought for by the Applicant/Appellant. In the Appellant's last communication to the Commission dated 17.08.2015, he had submitted that he was yet to receive the information.

In view of the facts brought out above, the Commission hereby orders the following -

- 1. The SPIO shall furnish the information sought for by the RTI Applicant/Appellant, free of cost, within a period of 10 days of receipt of this order, if not already done.
- The SPIO shall submit an explanation to the Commission, within a period of 15 days of receipt of this order, as to why penalty shall not be imposed on him/her Under Section 20 (1) of the RTI Act, 2005 for his/her failure to furnish the information to the Applicant within the stipulated period of 30 days.

3. The FAA shall hear the First Appeal dated 09.12.2014 by the Appellant and pass an appropriate speaking order in compliance with the relevant provisions of the RTI Act, 2005, within a period of 21 days of receipt of this order.
