<u>O R D E R</u> 19.2.2016

The Public Authority is represented by Shri Pradeep Kumar Rajbongshi, APS, Dy.S.P., Assam Police Headquarters accompanied by Shri Paresh Boruah, ASI of police. The petitioner Shri Dulal Bora is absent. However, he has sent an application dtd 10.2.16 praying for refixation of the date of hearing as he is unable to attend today's hearing due to personal problems. In view of the large number of pending cases before this Commission, the Second Appeal petition dtd 17.5.13 is taken up for consideration on merit ex-parte in absence of the petitioner.

From perusal of the case records it is seen that the petitioner Shri Dulal Bora filed an RTI petition dtd 5.3.13 before the Director General of Police, Assam seeking information on the issuance of police verification report in respect of a person accused in a murder case and who spent some time in judicial custody. The AIGP (A) and SPIO of Assam Police Headquarters has sent a written submission dtd 15.2.16 enclosing a copy of the information furnished by the SP, SB (E) vide letter dtd 25.3.13. The SP, SB (E) informed the petitioner that there was no specific case reference mentioned in the RTI petition. Hence the information could not be furnished.

The Commission also observes that the RTI petition dtd 5.3.23 is not specific because it does not refer to any particular police case of any Police Station and also whether the police verification report was positive or negative.

This Commission, therefore, directs the petitioner to give specific details of the case within 15 days from the date of receipt of this order to the SP,SB (E) in respect of which he wants the information and also indicate whether the information sought for is with reference to a positive PVR or a negative PVR. SP, SB (E) is directed to furnish the information to the RTI applicant within 30 days from the date of receipt of the above information from the applicant

With the above order the Second Appeal petition dtd 17.3.13 is disposed of.
