O R D E R

SPIO/E.O., Jamadarhat Development Block, Dhubri along with Secretary, Chirakuti Gaon Panchayat and Ex-Secretary, Jamadarhat Gaon Panchayat present.

Appellant absent with a written apology.

The SPIO submitted that although the information sought for could not be provided in time, the concerned GP readied the information and sent it with a forwarding letter dated 28/1/2016 to the Petitioner by a special messenger but the same was refused to be received by the Petitioner in view of the ensuing hearing. A copy of the forwarding letter dated 28/1/2016 has been produced before the Commission which has a note recorded in his hand by the messenger-Peon dated 30/01/2016. The SPIO apologized for the delay in furnishing the information.

In view of the facts brought out above, the Commission hereby orders that the information sought for by the Appellant/Petitioner shall be provided, free of cost, within a period of 10 days of receipt of this order, by registered post.

No evidence of disposal of the First Appeal Petition dated 2/7/2012 submitted by the Appellant/Petitioner to the C.E.O., Dhubri Zilla Parishad has been received in the Commission. As the concerned B.D.O. is the appropriate authority, the B.D.O., Jamadarhat Development Block, Dhubri shall consider and dispose of the aforementioned First Appeal, with a speaking order, within a period of 15 days of receipt of this order.

A copy of the RTI Application dated 23/5/2012 and that of the First Appeal dated 2/7/2012 be forwarded to the B.D.O., Jamadarhat Development Block.

The Second Appeal Petition is hereby disposed of.
