The DEEO, Nagaon with his Senior Assistant present. A Written Submission dated 01.02.2016 also received.

The Petitioner absent without any information.

Perused the W/S made by DEEO, Nagaon. It has been submitted that the case file relating to the RTI Application dated 22.05.2012 could not be traced, and that the case has been reconstructed with the help of another RTI Application by the same Appellant on a similar matter. It has further been submitted that the DEEO, Nagaon had taken over the current charge a few months back. The DEEO, Nagaon had convened a meeting with the Petitioner and the concerned BEEO, namely BEEO, Juria wherein the Petitioner could not confirm whether he had received the information. The DEEO, Nagaon has sought 15 days time to furnish the information.

In view of the facts brought out above, the Commission hereby orders that the information sought for by the Appellant/Petitioner shall be provided, free of cost, within a period of 15 days of receipt of this order.

Further, the District Elementary Education Officer (DEEO), Nagaon as First Appellate Authority shall consider and dispose of the First Appeal dated 01.08.2012, with a speaking order, within a period of 21 days of receipt of this order.

The Second Appeal Petition is hereby disposed of.
