A perusal of the case records indicate that the information sought for through the RTI Application dated 30/3/2013 is non-specific in nature and is similar to the RTI Applications by the same Applicant dated 8/3/2013, 18/2/2013 and 30/3/2013 filed with the same Public Authority, namely Deputy Commissioner, Nagaon. The Second Appeal cases bearing numbers SIC/NGN.52/2013, SIC/NGN.53/2013 and SIC/NGN.54/2013 respectively relating to the said Applications dated 3/8/2013, 5/8/2013 and 3/8/2013 by the same Applicant, namely Sri Dulal Bora, were heard by the Commission on 22/1/2016 and on the prayer by the Applicant the said Second Appeal cases had been disposed of and orders issued thereon.

Considering that the information sought through the RTI Application involved in the instant Second Appeal case is of general, non-specific in nature as in case of the other three cases cited above, the same (SIC/NGN/57/2013) is hereby disposed of.
