<u>ORDER</u>	

Neither party present. However, a Written Statement dated 20.02.2016 has been received from the Chairman, Silchar Municipal Board, Cachar.

The Appellant has not sent any communication as to whether he has received the information subsequent to his filling of Second Appeal dated 20.07.2013.

Perused the abovementioned W/S. Through the W/S time has been sought to enable the Public Authority to trace out the RTI Application case papers stating that the Board had taken charge 'only' on 02.04.2015 and that the office had been shifted to a new building.

The Appellant had filed the Second Appeal being aggrieved by the failure of the SPIO, office of the Silchar Municipal Board to furnish the information he had sought for and failure also of the First Appellate Authority (FAA)/D.C., Cachar to fulfill its responsibility to enable to RTI Applicant/Appellant to receive the information that he had sought for.

Perused the case records. It is seen that, unless the information had been provided subsequent to filling of the Second Appeal, there has been much delay on the part of the SPIO to fulfill its responsibility under the RTI Act, 2005 to provide information sought for within a specified period. It is also seen that the delay has been inordinate given the fact that the RTI Application was made on 15.04.2013 and First Appeal on 01.06.2013. In view of this delay, the Commission decided to go ahead with today's hearing *ex parte* in the interest of the Appellant in accordance with the said Act.

There is no evidence of the FAA having disposed of the said First Appeal in accordance with the said Act.

In view of the facts stated above and keeping in view the request of the Public Authority for time, the Commission hereby orders the following –

- 1. The SPIO shall furnish the information as sought for by the Applicant/Appellant, free of cost, within a period of 21 days of receipt of this order, and
- 2. The First Appellate Authority/D. C., Cachar shall consider and dispose of the First Appeal dated 01.06.2013, with a speaking order, within a period of 30 days of receipt of this order.

With this, the Second Appeal Petition is disposed of.

The Appellant/Applicant shall be at liberty to submit a Complaint of non-compliance in case he is not satisfied with the action taken in accordance with this order.
