**O R D E R**

Neither party present.

However, the Complainant has submitted a letter dated NIL stating that he has not received the information he had sought for from the Narsingpur Cooperative Societies Limited, Cachar.

The SPIO has not submitted any Written Statement on the status of furnishing of information which was sought for by the Commission through its hearing notice dated 06.02.2016. The SPIO has also not submitted any explanation as to why penalty shall not be imposed on him/her Under Section 20 (1) of the RTI Act, 2005 for his/her failure to furnish the information to the Applicant within the stipulated period of 30 days.

The RTI Applicant had submitted the Complaint dated 23.08.2013 to the Commission when he did not receive the information he had sought for through his Application dated 20.07.2013.

In view of the facts brought out above, the Commission hereby orders the following-

1. The SPIO/Secretary, Narsingpur Cooperative Societies Limited, Cachar shall furnish the information as sought for by the Applicant, free of cost, within a period of 10 days of receipt of this order, and
2. The SPIO shall submit a written explanation to this Commission, within 15 days of receipt of this order, as to why penalty shall not be imposed on him/her Under Section 20 (1) of the RTI Act, 2005 for his/her failure to furnish the information to the Applicant within the stipulated period of 30 days.

The Complainant, at his discretion, may submit First Appeal with the appropriate First Appellate Authority in case he does not receive the information from the SPIO in terms of this order or is not satisfied with the information received. On receipt of such First Appeal, the First Appellate Authority shall consider and dispose it of in accordance with the RTI Act, 2005.
