**O R D E R**

18.02.2016

Sri Ripen Boro, Translator along with Mir Abdul Latif, Translator attended as deputed by the SPIO, State Mission Office (SMO), SSA, Assam.

The Appellant present with his assistant.

The District Mission Coordinator (DMC), SSA, Cachar has sent a written request dated 17.02.2016 to fix another date of hearing on account of his preoccupation with the ongoing HSLC/AHM Examination.

Heard the Appellant. It has been submitted that he had received part of the information that he had sought for but the documents given to him in connection with the said information were not duly certified copies.

Perused the Written Statement dated 10.02.2016 submitted by the SPIO, SMO, SSA, Assam. It has been submitted that as reported by the DMC, SSA, Cachar information was provided to the Appellant through letter dated 25.11.2013 by registered post but that the same had returned to the office with the comment "Addressee not found". It is seen that the said DMC had written another letter to the Appellant dated 12.12.2013 providing certain information. It is also seen that the DMC had transferred point no. 8 of the Application to the BEEO cum BMC, Katigorah Educational Block, Cachar through a letter dated 22.11.2013 u/s 6 (3) of the RTI Act, 2005 with a direction to provide the information directly to the Appellant/Applicant.

The Appellant submitted that he has not received the said letter of the DMC dated 12.12.2013.

In view of the facts brought out above, the Commission hereby orders the following-

1. The DEEO cum DMC, SSA, Cachar shall review the information already supplied to the Applicant and provide him the information remaining to be furnished along with the related documents duly certified, free of cost, within a period of 10 days of receipt of this order.
2. The BEEO cum BMC, Katigorah Educational Block, Cachar shall furnish the information relating to point no. 8 of the RTI Application dated 10.09.2013 which had been transferred to him by the DMC, SSA, Cachar, free of cost, within a period of 10 days of receipt of this order.

In case the Appellant is not satisfied with the actions taken by the DEEO cum DMC, SSA, Cachar and the BEEO cum BMC, Katigorah Educational Block, Cachar in terms of this orders, he will be at liberty to submit a Complaint with this Commission.

With this, the Second Appeal Petition is disposed of.
