**O R D E R**

17.02.2016

Neither party present. Received a letter dated NIL from the BDO, Kalain Development Block, Hilara, Cachar requesting for fixing another date for hearing owing to his inability to attend today's hearing being preoccupied with NRC duty.

However, the Commission decided to go ahead with the hearing *ex parte* considering that the said BDO has not provided any information relating to receipt of the RTI Application and furnishing of the information as sought for by the Commission through its hearing notice dated 04.02.2016.

A perusal of the case records indicate the following sequence of significant dates:

- 17.12.12 RTI Application filed with the PD, DRDA, Silchar
- 18.04.13 RTI Application was transferred to the BDO, Kalain Development Block, Hilara, Cachar.
- 04.07.13 Complaint filed before the Commission.

In the absence of the Complainant or any communication from him, the Commission is not in a position to determine as to whether he had received the information he had sought for.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall furnish the information sought for by the RTI Applicant/Appellant, free of cost, within a period of 10 days of receipt of this order, if not already furnished.

Should the Complainant not be satisfied with the action taken by the SPIO in compliance with this orders, he may, at his discretion, file the First Appeal with the appropriate First Appellate Authority in accordance with the RTI Act, 2005.

With this, the Complaint case is disposed of.
