ORDER 17.02.2016

Neither party present. No Written Statement received.

In the absence of the W/S sought for by the Commission from the SPIO through its hearing notice dated 04.02.2016 and any communication from the Appellant, the Commission could not determine as to whether the remaining information has been furnished to the Appellant subsequent to his filing of the Second Appeal dated 29.08.2013.

Perusal of the case records indicate that in response to the First Appeal dated 03.07.2013 submitted to CEO, Cachar Zilla Parishad, Cachar, the latter had directed the Secretary, Dungripar G.P, Cachar, furnishing the information to the Applicant directly within 7 days. It is not known whether this direction from the CEO, Cachar Zilla Parishad, Cachar was complied with.

The FAA/CEO, Cachar Zilla Parishad, Cachar has not apprised the Commission about the steps he had taken to dispose of the First Appeal dated 03.07.2013 either by a Written Submission/or by deputing his authorized representative to the hearing which he was directed to do through the said hearing notice of the Commission.

In view of the facts brought out above, the Commission hereby orders the following-

- 1. The SPIO shall furnish the remaining information to the Appellant/Applicant as sought for through his RTI Application dated 08.05.2013, free of cost, within a period of 10 days of receipt of this order. If already not furnished, and in case any part of the information is not available to be provided, the position should be explained in writing to the Petitioner.
- 2. The FAA/CEO, Cachar Zilla Parishad, Cachar shall consider and dispose of the aforementioned First Appeal submitted by the Appellant, with a speaking order, within a period of 21 days of receipt of this order with reference to this order.
