O R D E R

The Appellant Shri Dulal Bora is present. The Public Authority to be represented by the SPIO of the Paltan Bazar Police Station is absent without information. The Second Appeal petition dtd 17.5.13 is taken up for hearing ex-parte.

From perusal of the case records it is seen that the applicant Shri Dulal Bora filed an RTI petition dtd 4.2.13 before the SPIO of Paltan Bazar Police Station, Guwahati. Not getting any response from the OC, Paltan Bazar Police Station he filed First Appeal petition before the Director General of police, Assam on 6.4.13 followed by Second Appeal petition dtd 17.5.13 before this Commission.

Vide his RTI petition dtd 4.2.13 the applicant wanted the Investigation Report of Case No. 982/2012, apparently of Paltan Bazar Police Station. When asked by this Commission why he wanted Investigation Report of the Paltan Bazar Police Station, the applicant stated that:- ***“He personally witnessed and intervened in a chain snatching incident that took place in Paltan Bazar area. He with the help of other witnesses and bystanders apprehended the culprits and handed over to the Paltan Bazar Police Station. The Case No. mentioned above refers to this incident.”*** The FIR in this case was filed by the applicant himself in his name, as stated by him before this Commission.

In view of the above, This Commission directs the OC, Paltan Bazar Police Station to give a copy of the Investigation Report in the above mentioned Case Number, i.e. Case No. 982/2012 of Paltan Bazar Police Station to the petitioner within 15 days from the date of receipt of this order.

With the above order, the Second Appeal petition dtd 17.5.13 is disposed of.
