O R D E R

The Appellant Shri Dulal Bora is present. The Public Authority to be represented by the SPIO of the office of the Commissioner of Police, Guwahati City is absent without information. The Second Appeal petition dtd 6.6.13 is therefore, taken up for hearing ex-parte in absence of any representative from the Public Authority concerned.

From perusal of the case records it is seen that vide his RTI application dtd 15.2.13 filed before the then Sr. Superintendent of Police, (City) Guwahati the applicant sought information on the administrative structure in terms of the Police Stations and Police Out Posts along with their manpower strength of different ranks, under the transitorial jurisdiction of SSP(City), Guwahati.

It is seen that the applicant is yet to be furnished the required information. This Commission, therefore, directs the present Commissioner of Police, Guwahati city to furnish the information sought for by the applicant as may be admissible under the RTI Act, 2005 taking into account information exempted by any of the sub-clauses u/s 8 of the RTI Act and manpower belonging to any of the organizations exempted from the purview of the RTI Act, 2005 vide Government of Assam, Political Department's notification No. PLA.384/2005/54 dtd 8th March, 2006, even though they may be attached with the Commissioner of Police, Guwahati City or any of his subordinate Police Station, Police Out posts, etc. The admissible information as sought vide the RTI application dtd 15.2.13 be furnished to the applicant within 15 days from the date of receipt of this order.

With the above order, the second Appeal petition dtd 6.6.13 is disposed of.
