The SPIO has not submitted any Written Statement on the status of furnishing of information which was sought for by the Commission through its hearing notice dated 17.02.2016.

The case records indicate that the Appellant had filed the Second Appeal with this Commission after he failed to receive the information inspite of an order of the First Appellate Authority (FAA) *i.e.* Inspector of Schools, HDC, Hailakandi.

In the absence of the Appellant in today's hearing and any written communication from him, the Commission could not determine as to whether he has received the information he had sought for subsequent to submission of the Second Appeal dated 28.04.2014.
