**O R D E R**  
04.03.2016

The CDPO i/c, South Karimganj ICDS Project present along with LDA of the office. A Written Statement dated 04.03.2016 has also been submitted by her.

The Appellant absent without information.

Perused the abovementioned W/S. It has been submitted that the RTI Application dated 24.04.2013 was filed during the period of her predecessor that she was not aware of the facts as she had taken over charge of CDPO in the month of December, 2014 and that the office was running with acute shortage of staff. It has further been submitted that the remaining information/documents sought for by the Appellant/Applicant have been prepared for furnishing to the Appellant/Applicant. It has also been submitted that the First Appeal is yet to be disposed of.

The Second Appeal dated 04.11.2013 submitted to the Commission was heard on 05.11.2015 with the order that the SPIO should provide the remaining information to the Applicant/Appellant within a period of 10 days of receipt of the order, free of cost and submit a written explanation as to why penalty shall not be imposed on him/her under Section 20 (1) of the RTI Act, 2005 for his/her failure to furnish the information to the Applicant within the stipulated period of 30 days. It had also been ordered that the First Appellate Authority (FAA) shall consider and dispose of the First Appeal submitted by the Appellant/Applicant, with a speaking order, within a period 21 days of receipt of the order.

In view of the facts brought out above, the Commission hereby orders that the remaining information/documents etc. shall be sent to the Appellant/Applicant by post, free of cost, within 5 days of receipt of this order. It is further ordered that the CDPO i/c as FAA shall consider and dispose of, with a speaking order, the First Appeal which had been transferred by the DSWO, Karimganj to the CDPO, South Karimganj ICDS Project through letter no. DSWO(K)180/RTI/Pt-I/2012-13/139 dated 19.08.2013, within a period of 15 days of receipt of this order.

With this, the Second Appeal case is disposed of.

As the SPIO had furnished the information, although in part, no penalty is imposed.
