**O R D E R**

The petitioner Shri Bipin Chandra Thakuria is present. The Public Authority is represented by Shri Chandra Mohan Sharma, IFS, Addl. PCCF and Mission Director, State Bamboo Development Agency, Assam accompanied by Shri Pranjal Sharma, Data Operator to assist him. The complaint petition dtd 5.7.13 is taken up for hearing in presence of both the parties in pursuance of this Commission's earlier order dtd 18.12.15 and 29.1.16.

Vide his RTI application dtd 13.3.13 the petitioner Shri B.C. Thakuria sought information on:-

- (i) Release of fund year-wise by Assam State Bamboo Mission to various development agencies.
- (ii) Names of various divisions and ranges where plantations have been created.
- (iii) Names of the reserve forests with GPS point and area of plantation created in hectare.

The Addl. PCCF, Shri C.M. Sharma, IFS and state Mission Director of Bamboo Development Agency has made a written submission dtd 6.2.16 before this Commission stating that he has meanwhile compiled the information as per his office records, a copy of which has been enclosed with the written submission.

When asked by this Commission, the applicant Shri B.C. Thakuria deposed in writing that he is still interested in getting the information. Therefore, his complaint petition dtd 5.7.13 is converted into an appeal petition as requested by him and this Commission directs the Addl. PCCF and State Mission Director, Bamboo Development Agency, Assam to hand over the information brought by him to the petitioner, which he did in presence of this Commission.

With the above order, converted Second Appeal petition stands disposed of.
