O R D E R

The appellant Sri A. K. Laskar is present. The public authority to be represented by the SPIO of the Assistant Director, Handloom and Textiles, Silchar is absent without any information.

The second appeal petition dated 7-6-2014 is taken up for hearing, ex parte in the absence of the public authority.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 28-6-2012 before the Assistant Director, Handloom and Textiles Department, Silchar, seeking information on implementation of various schemes for the Financial Year 2007-08 to 2011-12. Thereafter, he filed first appeal petition dated 13-8-2012 before this Commission. The First appeal petition was sent by this Commission on 14th August, 2012 to the Director, Handloom and Textiles, with a copy to the petitioner, Sri A. K. Laskar for disposal within 30 days.

Subsequently, apparently, due to not getting any response, the petitioner filed a second appeal petition before this Commission on 7-6-2014.

The petitioner deposed before this Commission that till date he has not been given any information by the Assistant Director, Handloom and Textiles, Silchar nor has the Director, Handloom and Textiles, Govt. of Assam given any hearing for disposal of the first appeal petition, in compliance with this Commission's order dated 14th August, 2012.

Send copies of the RTI petition dated 28-6-2012, copy of the first appeal petition dated 13-8-2012 and this Commission's direction dated 14th August, 2012 to the Director, Handloom and Textiles for disposal of the first appeal petition after giving a hearing to the petitioner within 30 days from the date of receipt of this order.
